Up to 24 hours before the start of the security service, the exhibitor is not entitled to any compensation in the event of cancellation Cost. If the exhibitor cancels the guarding contract 24 hours before the start of the guarding, he is obliged to pay 50% of the guarding fee (but at least 4 hours).
- The guarding service is owed, not the success. Messe Augsburg ASMV GmbH will have the guarding carried out by a guarding service provider.
- The exhibitor is obliged to inform Messe Augsburg ASMV GmbH of all events and circumstances which are of significance for the guarding could do.
- The exhibitor has no authority to issue instructions to the guards responsible for guarding.
- Complaints of any kind relating to the performance of the service or other irregularities must be submitted to the (+49 (0)821-2572-206) must be reported to the trade fair management.
- If the exhibitor does not fulfil his obligations arising from the contractual relationship, in particular from No. 3 of these Special Conditions for Ordering, the exhibitor shall be entitled to security services are provided in a manner deemed appropriate by the security service provider.
- The exhibitor shall provide Messe Augsburg ASMV GmbH with contact details of the exhibitor in the event of the object to be guarded being endangered, even at night, can be notified by telephone. Messe Augsburg ASMV GmbH must be informed immediately of any changes to this contact data.
- Maximum limits for the value of the objects to be guarded.  
The total value of the objects to be guarded may not exceed the value stated above by the exhibitor. Should the exhibitor require security of objects whose total value is higher than the above-mentioned amount, Messe Augsburg ASMV GmbH may, in agreement with its security company, make a claim in this respect.  
The insurance company, the service provider and its insurer will prepare a special offer which includes the increased insurance costs.
- Assertion of liability claims  
The exhibitor is obliged to assert liability claims immediately. Furthermore, the exhibitor is obliged to inform Messe Augsburg ASMV GmbH without delay of to give the opportunity to make all necessary determinations regarding the cause of damage, the course of damage and the amount of damage itself or through agents. Expenses incurred as a result of the exhibitor failing to meet his contractual obligations or failing to do so immediately shall be borne by him.
